The condition provided in this subsection must be satisfied by the local school board each year that the board proposes an opening date more than ten days before the first Monday in September.

The Chillicothe R-II School District will hold a Public Meeting for the determination of the beginning day of school for the 2014-15 school year on Tuesday, December 17, 2013 at 6:15 p.m. in the Chillicothe R-II Administrative Building.
